QUARRY UPDATE

The lawsuit (Article 78) filed against the Adirondack Park Agency (APA) and Red Rock Quarry Associates, LLC on behalf of AWLA and Protect the Adirondacks! has been set for review by the Oneida County Supreme Court on April 27th, though this may be delayed until July, as legal counsel for the APA has requested more time to prepare.

The Town of Forestport and Thomas Sunderlin have submitted a Phase I application to the DOT for the improvement of the intersection at Stone Quarry Rd and Rt 28; this application is currently under review with the DOT. The attorneys representing private White Lake landowners have presented their preliminary arguments in regards to the Stone Quarry Road intersection and road usage to the DOT and the Town of Forestport. The next Town of Forestport Planning Board Hearing is scheduled for Wednesday, May 11, 2022, whereupon the board will review the application regarding the proposed White Lake Granite Quarry.

SEPTIC SYSTEMS

Proper use and maintenance of your septic system is imperative and helps to protect the environment and our drinking water, as well as saves on costly repairs. Homeowners should pump their septic tank at regular intervals, as recommended by a professional, and be careful about what goes down the drain or gets flushed. Fats, grease, and disposable wipes clog pipes and drain fields. Proper septic maintenance ensures that groundwater is being protected from human contaminants. Inspect and pump frequently, use water efficiently, properly dispose of waste, and maintain your drain field.

BOAT LAUNCH & GATE FEES

The White Lake Shores Association (WLSA) has completed the upgrade of the boat launch at Beach A (across from White Lake Inn). As a reminder, AWLA has a gate contract with WLSA, which means our members can apply for a discounted gate pass with WLSA - access to Beach A with gate fob will cost \$50 seasonally. The gate agreement between our two associations states that all lakefront property owners MUST belong to AWLA before **obtaining a WLSA gate pass**. AWLA also has a boat launch on Purgatory Bay with the gate combination issued each season with your AWLA membership renewal. No matter which boat launch you, your guests, or renters use, all boats must be inspected and free of aquatic invasive species prior to entering our lake.

INVASIVE SPECIES BOAT INSPECTIONS

Inspection of boats – and if need be, boat washing – prior to launching on our lake is required by law and extremely important to stop aquatic invasive species from entering our pristine waters. This includes your renters and guests! We have hired stewards seasonally since 2016. We will continue our Steward Program this summer, with lake steward staff onsite weekends. Thank you for adhering to these requirements and keeping our lake invasive species free.

BOATING SAFETY REMINDER

Please be familiar with and adhere to safe boating practices. White Lake is relatively small, especially with the amount of boat traffic that can occur on weekends and holidays, so be courteous, respectful, and aware of fellow boaters. Parents, if your children are out on the lake, check in to make sure they are aware of and observe all boating safety regulations. AWLA & WLSA will be coordinating efforts to identify offenders of boating safety guidelines. We can have fun and be safe! There will be a class offered on **June 25th**, **2022** at the Forestport Town Hall, 10275 State Route 28, Forestport, New York. This class, as well as other boater safety classes, begin promptly at 9:00 A.M. Because it is an 8 hour class, it is recommended that everyone bring snacks, drinks, and/or a lunch.
